All Bids must include an Iran Sanctions Affidavit of Compliance.

Each bid shall be accompanied by a certified check, cashier's check, money order or bid bond made payable to Southfield Public Schools in an amount not less than five percent (5%) of the Base Bid as a proposal guarantee. Bid Bond shall be provided by a company licensed to do business in the State of Michigan.

A pre-bid conference and walk-thru is scheduled for May 15, 2026, at 2:00 PM local time. Bidders shall meet at Levey Middle School located at 25300 West 9 Mile Road, Southfield, Michigan 48033.

Successful bidders whose proposals are \$50,000 or more will be required to furnish a Satisfactory Performance and Payment Bond in the amount of 100% of their bid. The cost of the Bond shall be included in each proposal.
